In view of the Government's initiative to enhance employability and skill development among students, it is imperative that all State Public Universities, Government Colleges, and Non-Government Colleges actively participate in the Prime Minister's Internship Scheme. This scheme aims to provide valuable internship opportunities to outgoing students and ex-students, enabling them to gain practical experience and enhance their career prospects. **The PM Internship Portal for round 2 is opened from 12th February, 2025 to 12th March, 2025.**

To ensure effective implementation and awareness of the scheme, the following actions are to be undertaken at the earliest:

- 1. Appointment of Nodal Officer:** Each university and college is required to designate a Nodal Officer for the PM Internship Scheme. The Nodal Officer will be responsible for coordinating and overseeing all activities related to the scheme.
- 2. Awareness Programmes and Workshops:** Universities and colleges should conduct awareness programmes and workshops to inform students and alumni about the benefits of the PM Internship Scheme. These sessions should involve NSS Volunteers, Self-Defence Training Groups, and various student clubs to maximize outreach.

3. **Web Portal and Online Information Display:** Institutions should create dedicated web portals or update their existing websites with relevant information about the PM Internship Scheme. Additionally, details should be prominently displayed on notice boards for easy access by students and alumni.

4. **Stakeholder Communication through WhatsApp Groups:** Institutions are encouraged to form WhatsApp groups involving faculty members, student representatives, and alumni to facilitate smooth communication and ensure timely updates regarding internship opportunities.


The Guideline of PM Internship Scheme is enclosed herewith for reference.

You are requested to ensure compliance with the above directives at the earliest and submit an action taken report to the Higher Education Department on weekly basis.


